3. Transition Audit Duration

Key requirements concerning the need to determine appropriate audit duration:

2. CMA will calculate the on-site audit duration as follows:

2.1. The on-site audit duration for the transition to the 2016 edition of the applicable AQMS standard shall be determined from AS9104/1 requirements for the applicable audit.

2.2. CMA shall further increase the on-site audit duration to effectively audit the changes to the certified organization's QMS that occurred to support conformance to the revised AQMS standard(s).

- 2.2.1. Transition during Surveillance 30 % additional time to the normal surveillance duration
- 2.2.2. Transition during Recertification 15% additional time to the normal recertification duration
- 2.2.3. Transition during a Special Audit 30% additional audit time, similar to 2.2.1
- 2.2.4. A Zero addition for transition on-site audit duration is not permitted.
- 2.3. The audit duration shall be tailored to each individual certified organization.

2.4. The round up required by AS9104/1 clause 8.2a shall only occur once after all other calculations are complete.
